SUBJECT: 2025 HOME Homeowner Rehabilitation Program Funding Recommendation

Attached is the scoring matrix associated with staff's recommendation of funding awards under the 2025 HOME Homeowner Rehabilitation Program Description. THDA had over \$11.4 million in project funding available, including nearly \$4M in unspent funds from prior year allocations. THDA also transferred over \$2.9M in 2025 funds unawarded under the HOME Rental Housing Development Program.

THDA received 26 applications requesting \$17,425,924 in HOME project funds and \$1,394,074 in administrative funds. All applications were eligible for scoring. Per the 2025 Program Description available funding was divided evenly by Grand Division and applications first were scored and ranked by Grand Division. Once all applications that could be fully funded in each Grand Division were determined, all applicants remaining unfunded were ranked by score and the balance of the funds were awarded without regard for location. Note that any scoring ties were broken based first on the Need score and then, if a tie still remained, by the Not Proportionally Served, score of each application. The attached funding matrix outlines the scoring and funding results.

Staff recommends the award and funding of 19 applications, in the amount of \$11,425,925 in program funds and \$914,074 in administrative funds that will help to rehabilitate 109 homes.
